

## Prayer Guide: November 2024

The guide is in three parts: an introduction to the theme; a written prayer or collect; and finally, specific items for prayer on the theme and for this month.

## **Budgets, Tax and Employment Law**

Government plays an important role in the economy – through budgets determining tax revenues and public spending, and legislation concerning employment rights, health and safety, financial regulation and much more. The new UK government's first budget (delivered October 30<sup>th</sup>) has been talked about since before the election, and the <u>Employment Rights Bill</u>, introduced to parliament on October 10<sup>th</sup>, will eventually¹ bring important changes to the world of work – for employees and employers.

The structure of our economy – the rules and culture of how we work, how much tax we pay, and what it is used for – should be topics for prayer. This is about fairness, justice, the relationships people have with each other, and how we care for the most vulnerable. It touches on the fundamental practicalities of life – access to goods and services, and the contribution each person makes to the common good.

Such things are at the heart of the Gospel of Jesus Christ, whose mission is to bring 'life in all its fulness' (John 10 v 10) and who teaches his followers to love God, and neighbour (Mark 12 v 28 - a reading set for Nov  $3^{rd}$ ).

- Good use of the tax system, to tackle inequality and provide vital public services, and for all who work in the tax system.
- FWW, for new volunteers as chaplains, trustees, and supporters to allow the development of new chaplaincy and encourage and support the mission of the whole Church within economic life across Worcestershire.
- Give thanks for the opportunity of taking part in the Discover Chaplaincy event in Redditch on October 24<sup>th</sup>, and pray for those discerning whether God is calling them to a role in the work of FWW.
- In our cycle of prayer for the work of FWW, this month we pray for:
  - chaplains in Alvechurch Sue Brotherton and Helen Ayling.
  - FWW Trustees at an extra meeting on November 7<sup>th</sup>, considering detailed planning to become a volunteer led charity by the end of 2025.
